



## Waiver/Release

### RELEASE OF LIABILITY FOR MINOR or PARTICIPANT READ BEFORE SIGNING

IN CONSIDERATION OF (Participant Name): \_\_\_\_\_ myself or my minor child/ward ("my child"), being allowed to participate in any way in the Tachyon Training Center programs, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury to myself, my child from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for myself, my child's participation; and,
3. I hereby grant permission to Tachyon Training Center personnel to handle any emergencies legally in the case that all emergency contacts cannot be reached. Furthermore, I grant permission for myself, this minor to be taken to the emergency room of a nearby hospital, and the hospital and medical staff have my authorization to provide treatment which a physician deems necessary for the well-being of myself or this minor.
4. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in myself, my child's readiness for participation and/or in the program itself, I will remove myself, my child from the participation and bring such attention of the nearest official immediately; and,

I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE THE other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to myself, my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
